eStatements

eStatements are electronic versions of your statements that can be accessed through internet banking. When you register for eStatements you'll no longer receive paper statements which is more convenient for you, and better for the environment.

Some things you need to know:

- Once you register an account for eStatements, you will no longer receive a paper statement for the account
- You will need to provide a valid email address, which must be regularly checked so we can tell you when your statement is ready and provide you with information from time to time
- We may remove accounts from being viewable through eStatements. If this happens, paper statements will resume for those accounts.
- You may enable or disable accounts for eStatements at any time using the preferences section in Heritage on-line, completing this form or by calling 13 14 22
- Some accounts are not eligible for eStatements
