Interpretation

Defined terms *italicised* in this Authority Form have the meaning given to them in the Heritage Business Banking Facility Terms & Conditions, available at any of our branches or by calling 13 14 22.

Redraw Option

The redraw option only applies if:

- You sign this redraw authority form; and
- The *facility* is a Fully Drawn Loan; and
- You pay any applicable fees; and
- The redraw option is available for your *facility*.

Withdrawals under redraw option

If activated, you can make a withdrawal under the online redraw option subject to the Heritage Online (business internet banking) terms set out in your *agreement*.

You'll need to consider the amount of your next payment and ensure there are sufficient funds available to cover this payment

and future payments. Redrawn *payments in advance* will form part of the *total amount owing* and interest is payable on the redrawn amount.
