When to use this form

This form is required when the Beneficial Owner has not completed an Addition of Party Form and is required to provide identification.

Why does Heritage collect this information?

Under the Anti-Money Laundering and Counter-Terrorism Financing Act 2006 we are required to collect and verify the details of Beneficial Owners of our customers. A Beneficial Owner is defined as 'an individual who ultimately owns or controls (directly or indirectly) the customer' (for more details visit www.austrac.gov.au). You have been identified as a Beneficial Owner and are required to complete this form.

This form does not authorise access to the customer's accounts unless the account holder has signed the 'Authority to Access Account' section.

Foreign Residency Tax requirements

As a financial institution we are not allowed to give tax advice.

Heritage is required by law to identify accounts held by foreign country tax residents and report information in regards to these accounts to the Australian Taxation Office. You may need to consult a tax professional for advice on completing your foreign tax residency status.

The term 'TIN' means Taxpayer Identification Number or a functional equivalent in the absence of a TIN. A TIN is a unique combination of letters or numbers assigned by a jurisdiction to an individual or an Entity and used to identify the individual or Entity for the purposes of administering the tax laws of such jurisdiction.

Some jurisdictions do not issue a TIN. However, these jurisdictions often utilise some other high integrity number with an equivalent level of identification (a 'functional equivalent'). Examples of that type of number include, social security number for US citizens.

Identification requirements

In addition to this form, Heritage is required to identify you. You may consent for Heritage to verify your identity electronically (see page 3), alternatively you will need to supply identification as per the <u>Membership ID Requirements</u>. If you are unable to present identification in-branch please refer to the <u>Identification Certification Information Sheet</u>.
